- Beginning June 8 – Letter containing space number and information mailed to vendors in 2018 show.
- August 3 – **NO REFUNDS** after this date.

What we DO accept in the Art & Craft show

- Only original work handmade by the artist is eligible for sale, including authors.

What we do NOT accept in the show

- NO items contracted out and/or made by someone else and/or resale items. Items must be at least 60% made by the vendor (e.g., clothing with added handiwork).

Vendors must carry their own insurance.

Directions for 2018 Application

1. Complete the fillable form, save & print.
2. Complete form ST-19, save & print (MN Tax ID)
3. Prepare a self-addressed, stamped, business-size envelope & include with your application, so we can mail you information
4. Write a check in the amount of the size booth you've checked on the application
5. **Mail all the above along with images of your work (see below) in an envelope with sufficient postage before the deadline.**

ARTIST IMAGES – Mail with your application

- 3-5 photos (actual photos).
- **Or**, 3-5 JPEG digital images loaded on a CD.
- New applicants -- submit a photo or digital image of your booth.
