Art of the Lakes is clearing the gallery to make room for a special exhibition featuring the many talented residents in the region who are makers! We invite you to submit your best work for this non-juried art exhibition. A reception will be held Saturday, January 13 from 4-6 pm. All are invited to attend.

ELIGIBILITY

We encourage creative people 18 years and older who reside in Battle Lake or the surrounding Lakes Region to apply. Makers need not be AOTL members to participate.

MEDIA

Painting, drawing, printmaking, photography, sculpture, ceramics, textiles, glass, and mixed media.

TERMS

1. There is a \$10 entry fee for submitting up to two (2) pieces. Eligible AOTL members receive an \$8. discount for up to two (2) pieces. Maximum size of 2D work is 36" w x 36" h. Maximum size of 3D work is 24" w x 24" h x 24" d.
2. By submitting an artwork, you confirm that the artwork is created solely by you, the maker and nothing depicted in the artwork is owned by a third party.
3. Only pieces dropped off at the Art of the Lakes gallery on either Friday or Saturday, January 5-6, 2024, between 10-4 pm will be accepted.
4. All artwork must be appropriately framed and ready for display in an art gallery format. Hanging work must have a hanging wire with no sawtooth hangers.
5. All work must include the artist's name and title of the work indicated on the back.
6. The exhibit will be on display in the Art of the Lakes Gallery in Battle Lake from January 12 to February 11, 2024. A reception will be held Saturday, January 13 from 5-7 pm with beverages and appetizers. Entries must remain on exhibit throughout the exhibition.
7. Art of the Lakes assumes the right to use any images of the artworks provided by you and reproduce the artworks for documentation, publicity, publication, education, and all other purposes, in print and digital forms, connected with the exhibition.
8. Art of the Lakes reserves the right to accept or deny admission of artwork into the exhibition. Artists will be notified by email on Thursday, January 11 if their work will not be included in the exhibition.
9. If you wish to sell your work, Art of the Lakes will take a 30% commission on the sale price of any artwork sold during the show. Please price your pieces accordingly.
10. Artwork must be picked up at the Art of the Lakes Gallery Sunday, Feb. 11 by 5 pm. To arrange an alternative pickup date, please call the gallery at 218-864-8606. Artwork that has been unclaimed after 1 month will become property of Art of the Lakes, either being added to our collection of artwork or sold as part of a fundraiser for the organization. Art of the Lakes will not ship artwork back to participating artists; all artwork must be picked up in-person.
11. Liability – All reasonable care will be taken with artwork. Art of the Lakes staff and volunteers cannot be held responsible for loss or damage to artwork including frames and mountings, no matter how damage/loss is caused. All entries submitted are subject to this condition. We suggest that artists insure work privately if they feel the need for such protection.
